PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING TO INSTALL OR USE THIS PROGRAM: A.K.Microsystems International Pty Ltd's End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and A.K.Microsystems International Pty Ltd (hereafter A.K.Microsystems) for the A.K.Microsystems software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA.
